ACCIDENT CHECKLIST

In the event of an accident immediately:



Stop immediately. Avoid obstructing traffic if possible.



Check for personal injury & seek medical attention if necessary.



Set emergency signals to prevent further damage or injury.



Call for police assistance & ask that an accident report be completed.



If you have a camera or mobile device, take pictures of all vehicle and/or property damage.



Gather the necessary information to complete the form on the back. Be sure to get the names, addresses & phone numbers of the occupants in all vehicles involved in the accident, as well as all witnesses.

DO NOT



Leave the scene of the accident.



Discuss the accident or admit fault.



Drive the vehicle if it is unsafe.



Take photos of the scene if it puts you or others at risk.



Allow your driver's license to be photographed.
